Applications are invited from meritorious **I B.Sc. (Hons.) ABM, students** admitted during 2021-22 under Agriculturist quota-Rural category for award of Mythri Meluku-1983 batch of Agri., Horti. & ABM graduates of UAS, Bangalore Endowment Scholarship for the Academic year 2021-22.

The following are the terms and conditions for the award :

1. The scholarship will be awarded to one eligible I year B.Sc. (Hons.) Agri. or B.Sc. (Hons.) ABM, students admitted under Agriculturist quota in Rural category at alternate cycle of once in four years, following the University guidelines for award of UG scholarship.
2. The value of the scholarship will be from out of the interest and on the sum of Rs. 2,00,000/- being equally divided for 12 months. This will be worked out every year and notified.
3. The scholarship will be terminable, withdrawn, if the conduct, progress and attendance of the student are not satisfactory, commits any indiscipline or indulge in malpractices, deliberately stay away from the classes.
4. If, the scholarship awardee student, subsequently joins the free hostel or avails free hostels facility and for reasons of his/her own discontinues the students in the middle of the year, the scholarship can be awarded to the next merit student in the panel.
5. The above scholarship shall be awarded by the University scholarship award committees annually along with other scholarships.
6. The scholarship will be renewed for the II, III and IV year on satisfactory progress / promotion of the student.
7. The renewal award of the scholarship during subsequent years will be in accordance UAS regulations issued from time to time subject to maintenance of satisfactory progress, good conduct and regular attendance.

Eligibility

1. Applicants parents annual income less than Rs. 1,00,000/- (Rupees one lakh only) are only eligible to apply for the scholarship (copy of the income certificate issued by the competent authority should be enclosed).
2. Eligible candidates can obtain applications from the office of the Deans of respective College from the date of notification. The filled-in prescribed application form along with the necessary Documents may be submitted to the concerned Dean on or before **30.04.2022**
