For outside the University, the last date announced by the University concerned may be followed.** Separate applications should be submitted for each subject in the prescribed proforma and if applied for more than one subject enclosures may be sent along with any one application only.

Applications received after the last date will not be considered and no advance copy will be entertained.

Further, the candidates may seek admission in any of the following Institutions and avail deputation facility outside University of Agril. Sciences, Bangalore within one year from the date of notification of selection, failing which the deputation shall stand cancelled and no extension of time will be granted.

3. Deemed Universities recognized by ICAR / ICAR Institute.
